

### **National Media Campaign**

Last April, AKF launched a nationwide media campaign in English and Spanish with the goal of reaching populations of color with prevention and awareness messaging. All campaign tactics to-date have exceeded estimated performance projections.

- TV, Streaming & Radio PSAs: Distributed nationwide to platforms including Amazon video, YouTube, Warner, Viacom, Univision, Telemundo. Achieved over \$1 million milestone in est. donated media and generated nearly 18 million est. impressions.
- Out-of-Home Placements: In 2024 we were in 8 markets with high rates of kidney disease, including billboards, bus shelter and interior bus ads. Delivered over 42 million est. impressions. We will add 8 new markets in 2025.
- In-Doctor's Office Campaign: Video PSAs running in primary care offices in markets with high rates. Culminated in nearly 3 million estimated impressions.
- Digital Media Campaign: Digital ads and user generated videos driving traffic to KidneyHealthForAll.org. Generated 4 million estimated impressions and over delivered over 40,000 individuals to KHFA.org










### **APOL-1 Kidney Disease Awareness Day**

**April 29, 2025** 

This past April 30th, AKF celebrated the first-ever APOL1-Mediated Kidney Disease (AMKD) Awareness Day. Leveraging earned and paid media and grassroots partnerships, we sparked a national conversation about AMKD and how communities can better understand their risk.

- Free, community health education program that trains participants to be about kidney disease
- Continuing education credits are available for allied healthcare professionals
- Prevent CKD and kidney failure through education and reach people in their communities across the United States, tribes, and territories
- Over 6,500 Kidney Health Coaches worldwide (up from 967 coaches in 2018)

### **KHC Health Equity Grants**

- One-year grants to help organizations and individuals overcome financial barriers to implementing KHC programs and spread CKD awareness and education to atrisk populations
- 40 coaches and 8 community organizations will receive \$100,000 in 2025



### **AKF Grassroots and Policy**



### **Health Equity Events for Ambassadors**

- Atlanta, GA Hosted on March 23, 2024. Multiple local organizations participated to discuss their programs. Speakers included:
  Bobby Howard, Director, Multicultural Donation Education Program; LifeLink of Georgia; DaVita; Lynne White from the Georgia
  Transplant Foundation and Paul Lee, Medicare Counselor, State Health Insurance Assistance Program.
- Springfield, MA We partnered with IPRO ESRD Network (ipro.org), which operates under the direction of CMS. The IPRO ESRD Network Program supports the renal community in ensuring safe, effective, patient-centered care for more than 132,000 kidney patients in 13 states.
- Chicago, IL Organized with the help of local Ambassadors Jim Myers and Kyle Chang, representatives from the office of
  Congresswoman Robin Kelly (D-IL) and the office of Senator Tammy Duckworth (D-IL). Both spoke about their offices' work to improve
  care for kidney patients and the importance of community members sharing their experiences to educate members on the impact of
  kidney disease on their lives.
- Columbia, SC Our final event was on November 9 in Columbia, SC, where there are enormous racial health inequities. For example, the 29203 zip code has the largest number of diabetic amputees in the nation. Speakers will include Nzisa Mutinga, Nephrologist at Columbia Nephrology Associates and Brittany Dickerson, Patient Advocate.
- Washington, DC -- As part of our health equity work, we had a booth at the Congressional Black Caucus Foundation's Annual Legislative Conference in September. Six Ambassadors attended the conference and shared their stories with ALC attendees at the booth.



- On Sept. 18, we hosted our second Rare Kidney Disease Advocacy Day, connecting patient advocates and health care professionals with lawmakers on Capitol Hill.
- During this advocacy day, members of AKF's recently launched <u>Rare Kidney Disease Action Network</u> (<u>RKDAN</u>) were paired with AKF staff members to participate in meetings with their elected officials.
- Representing 17 states, 23 advocates had 53 meetings with their senators' and representatives' offices, including nine meetings with members of Congress in attendance.
- Participants urged House of Representatives offices to cosponsor the New Era of Preventing End-Stage Kidney Disease Act (H.R. 6790) and Senate offices to consider introducing a Senate version of the bill. In addition, advocates asked offices to support the Access to Genetic Counselor Services Act of 2023 (H.R. 3876/S. 2323).

### 2025 Federal & State Policy Agenda

- Improving early detection of kidney disease and addressing the unknown causes of kidney disease
  - Encourage the U.S. Preventive Services Task Force to develop a CKD screening recommendation
  - Increase access and expand coverage of genetic testing and counseling
  - Increase awareness and resources for rare kidney disease
- Ensuring adequate funding for kidney research and promoting innovation
  - Ensure that Medicare ESRD PPS payments are adequate and support and encourage innovation
  - Increase funding for the National Institute of Diabetes, Digestive and Kidney Disease (NIDDK)
- Support living organ donation
- Supporting Medigap reform
  - Federal and state legislation to ensure the availability and affordability of Medigap supplemental insurance to all Medicare ESRD beneficiaries, regardless of age
- Protecting patient access to needed medications; supporting lower prescription drug costs
  - Appropriate implementation of the restructuring of the Medicare Part D benefit

### **Patient Access Initiative**

**November 19, 2024** 

#### **First Year Summit Recommendations Included:**

 Increased awareness/early diagnosis (including earlier and better screening for kidney disease, routine screening as part of the <u>Welcome to Medicare</u> benefit, genetic testing/counseling access)

• <u>Better patient education/navigation</u> (including a culturally competent approach, addressing health disparities and provider bias, support in insurance navigation)

• <u>Incentives for upstream investment in the early stages of CKD</u>: (including HHS/CMMI payment models, shared savings model, addressing utilization management challenges, financial incentives to payers and providers to treat earlier stages)

#### 2024 Activities:

- 2nd Annual Summit to be held in Washington, DC at the Darcy Hotel on November 19th
- Summit focus will be on upstream care for people with and at-risk for kidney disease:
  - The need for earlier screening and diagnostic testing, especially for higher risk populations
  - The role of caregivers and the need for mental health support in caring for people with kidney disease
  - Creating incentives for payers to cover upstream interventions to slow or stop the progression to ESRD
  - The need for more Innovation and access to treatments for CKD and rare kidney disease
